HAZUS is a regional multi-hazard loss estimation model that was developed by the Federal Emergency Management Agency (FEMA) and the National Institute of Building Sciences (NIBS). The primary purpose of HAZUS is to provide a methodology and software application to develop multi-hazard losses at a regional scale. These loss estimates would be used primarily by local, state and regional officials to plan and stimulate efforts to reduce risks from multi-hazards and to prepare for emergency response and recovery.

The flood loss estimates provided in this report were based on a region that included 1 county(ies) from the following state(s):

- Pennsylvania

Appendix A contains a complete listing of the counties contained in the region.

The geographical size of the region is 602 square miles and contains 2,440 census blocks. There are over 16 thousand households in the region and has a total population of 41,765 people (2000 Census Bureau data). The distribution of population by State and County for the study region is provided in Appendix B.

There are an estimated 14,443 buildings in the region with a total building replacement value (excluding contents of 2,247 million dollars (2002 dollars). Approximately 98.64% of the buildings (and 78.88% of the building value) are associated with residential housing.

## General Building Stock

HAZUS estimates that there are 14,443 buildings in the region which have an aggregate total replacement value of 2,247 million (2002 dollars). Table 1 and Table 2 present the relative distribution of the value with respect to the general occupancies by Study Region and Study Case respectively. Appendix B provides a general distribution of the building value by State and County.

### **Essential Facility Inventory**

For essential facilities, there are 2 hospitals in the region with a total bed capacity of 128 beds. There are 16 schools, 9 fire stations, 6 police stations and no emergency operation centers.

## **General Building Stock Damage**

HAZUS estimates that about 118 buildings will be at least moderately damaged. This is over 29% of the total number of buildings in the region. There are an estimated 9 buildings that will be completely destroyed. The definition of the 'damage states' is provided in Volume 1: Chapter 6 of the HAZUS Flood technical manual. Table 3 below summarizes the expected damage by general occupancy for the buildings in the region. Table 4 summarizes the expected damage by general building type.

Before the flood analyzed in this study case, the region had 0 hospital beds available for use. On the day of the study case flood event, the model estimates that 0 hospital beds are available in the region.

If this report displays all zeros or is blank, two possibilities can explain this.

(1) None of your facilities were flooded. This can be checked by mapping the inventory data on the depth grid.

(2) The analysis was not run. This can be tested by checking the run box on the Analysis Menu and seeing if a message box asks you to replace the existing results.

#### **Debris Generation**

HAZUS estimates the amount of debris that will be generated by the flood. The model breaks debris into three general categories: 1) Finishes (dry wall, insulation, etc.), 2) Structural (wood, brick, etc.) and 3) Foundations (concrete slab, concrete block, rebar, etc.). This distinction is made because of the different types of material handling equipment required to handle the debris.

The model estimates that a total of 14,505 tons of debris will be generated. Of the total amount, Finishes comprises 25% of the total, Structure comprises 42% of the total. If the debris tonnage is converted into an estimated number of truckloads, it will require 580 truckloads (@25 tons/truck) to remove the debris generated by the flood.

## Social Impact

#### **Shelter Requirements**

HAZUS estimates the number of households that are expected to be displaced from their homes due to the flood and the associated potential evacuation. HAZUS also estimates those displaced people that will require accommodations in temporary public shelters. The model estimates 219 households will be displaced due to the flood. Displacement includes households evacuated from within or very near to the inundated area. Of these, 273 people (out of a total population of 41,765) will seek temporary shelter in public shelters.

The total economic loss estimated for the flood is 64.93 million dollars, which represents 11.62 % of the total replacement value of the study case buildings.

#### **Building-Related Losses**

The building losses are broken into two categories: direct building losses and business interruption losses. The direct building losses are the estimated costs to repair or replace the damage caused to the building and its contents. The business interruption losses are the losses associated with inability to operate a business because of the damage sustained during the flood. Business interruption losses also include the temporary living expenses for those people displaced from their homes because of the flood.

The total building-related losses were 40.50 million dollars. 38% of the estimated losses were related to the business interruption of the region. The residential occupancies made up 33.59% of the total loss. Table 6 below provides a summary of the losses associated with the building damage.
