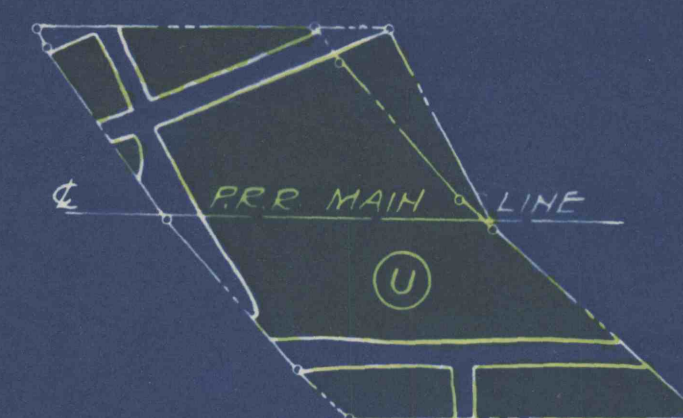


PILLARS AND BLOCKS OF COAL TO BE RESERVED SHADED GREEN

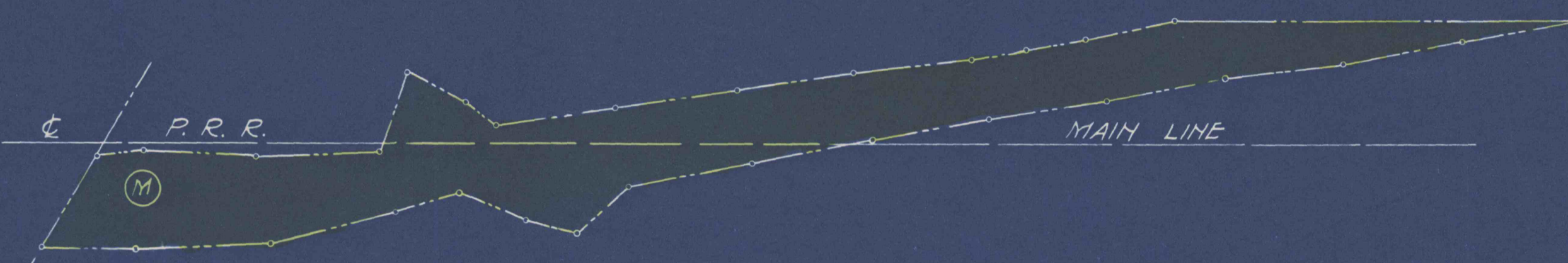

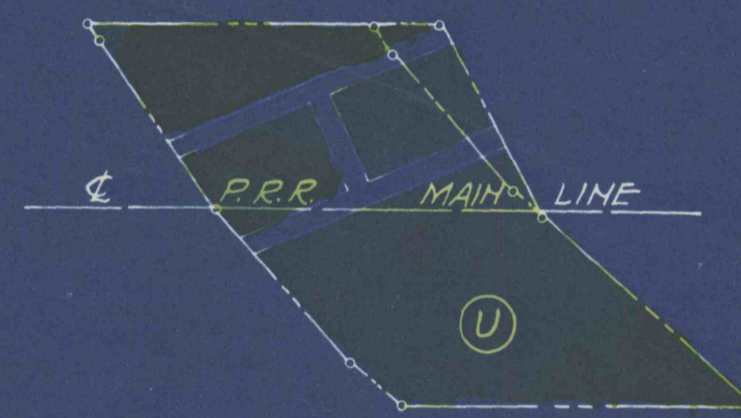

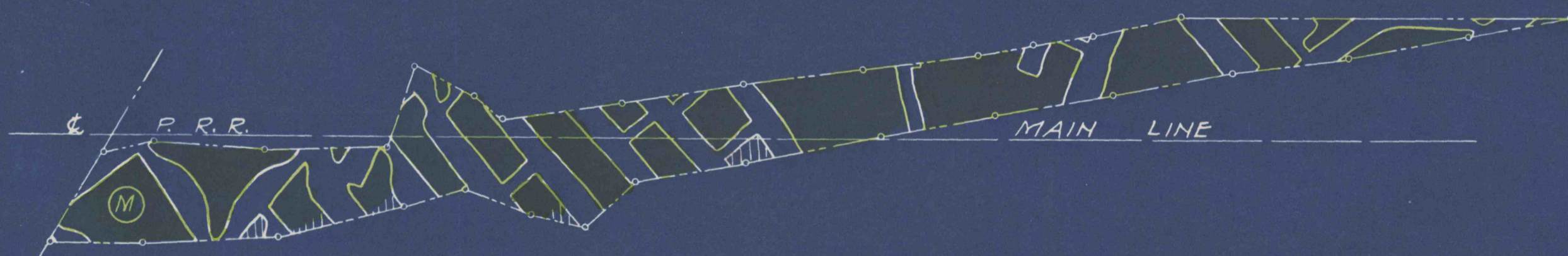

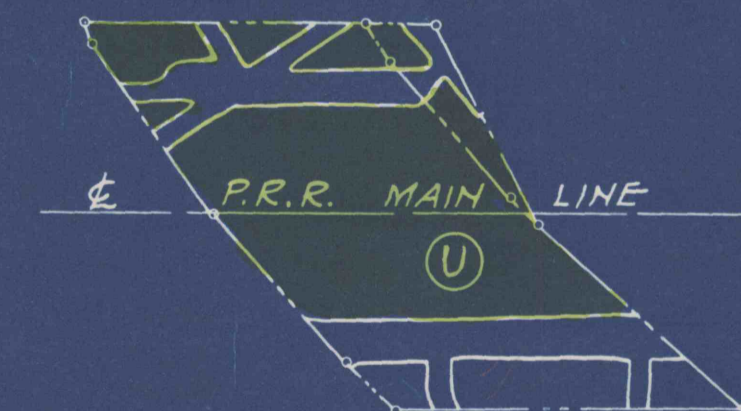
