One. Moffitt Mine of Salinas Brothers, in Dunkard Township, Greene County, Pennsylvania, was abandoned December 11, 1919. The portals and openings all have been sealed in compliance with the requirements of the Mine Safety Law.

Two. Moffitt Mine of Salinas Brothers was operated under a lease agreement with J. H. Williams & Sons Company. All the engineering work was done by J. H. Williams & Sons Company. The 100' water pillar of Moffitt Mine as shown on attached map and made a part thereof of a plan and contract copy of the original plan and contract copy of the mine workings as of December 11, 1919.
