This is the final map of the Rossmoyne No. 1 Mine. The CMAP No. is 32021301, MSHA ID No. 36-09075. The mine opening is located in S. Mahoning Twp., Indiana County. The mine was active in the Upper Freeport coal seam. Coal was first mined in April, 2003 and the final seals were inspected on November 29, 2011.

The mine surveying was per standard accepted mine surveying methods and procedures. The mine survey system maintained a minimum Linear Error of Closure and associated precision of 1:5000. The mapping is based upon Pennsylvania State Plane coordinates, South Zone, NAD 83. The final survey date is November 17, 2011.
