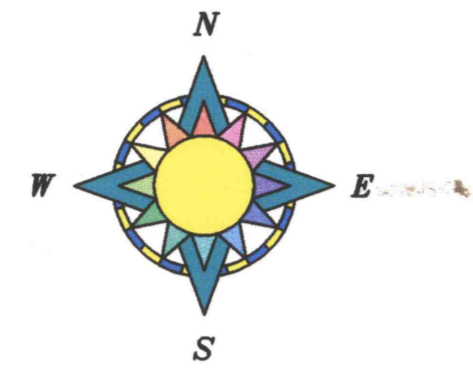

**MAP NOTES / COMMENTS**

There will be no mining on adverse properties until T.J.S. Mining, Inc. controls the coal rights.

Property lines are based on county tax maps, not actual field survey.

There will be no mining within 200 feet of any active and/or abandoned UPPER FREEPORT surface and/or deep mine unless it is specifically noted in the mine permit application.

The locations of the major gas lines (4" or greater) are based on gas company maps and have not been verified in the field.

The areas between the Mine Permit Boundary and the Subsidence Boundary are Hydrologic Barriers and are to be considered No Mining Zones.

Adjacent mine permit boundary areas have been shown slightly offset for clarity purposes. Generally these lines are coincidental to adjacent permit boundaries.
