The Save The Park Committee who did not want a part of the park to be used for the building.
In the end, the West End park site was abandoned as a site for construction of the municipal building after excavation work caused division of strong odors and it was determined the ground was contaminated with gas from an old gas works three years ago.
Todd said the one-story municipal building would be about 80 feet by 100 feet, and ground breaking would take place as soon as permission from Girard Estate and the Economic Development Administration was given.

Todd said he had not announced it because he was not sure what day the meeting would take place, and he is supposed to contact EDA to arrange a mutually convenient meeting date.
Conway asked who would attend the meeting. Todd said members of borough council's finance committee were supposed to attend, which is comprised of councilmen Joseph Capparel, Nick Corde, James Longon, Richard Lora, and himself.
Lola Heiser, who had been the spokesman of the Save the Park group, said that was one sided, apparently meaning that those going to meet with EDA did not include either one of the two Republican councilmen (who had supported the Save the Park group). Todd replied, "It's always one sided, that's the way it has been for years."
