



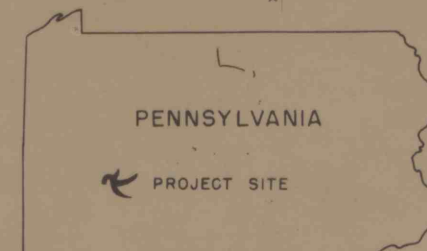
VICINITY MAP
