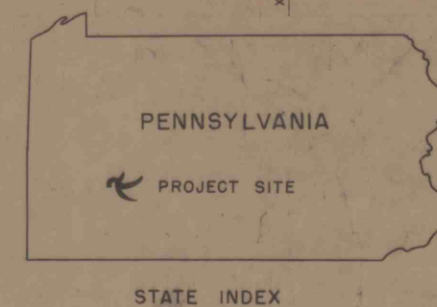


VICINITY MAP
