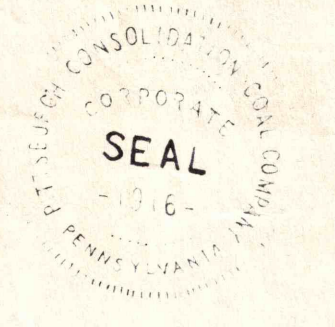


PLAN OF LOTS
