 OPENED AND ACQUIRED BY SAID BOROUGH,
 RESERVING AND EXCEPTING, HOWEVER, TO JONES & LAUGHLIN STEEL
 CORPORATION ITS SUCCESSORS AND ASSIGNS, ALL COAL IN AND UNDERLYING
 SAID STREETS, ROADS, LANES AND ALLEYS, TOGETHER WITH THE FREE AND
