



KNOW ALL MEN BY THESE PRESENTS: THAT JONES & LAUGHLIN STEEL CORPORATION, DOES HEREBY ADOPT THIS PLAN OF LOTS, KNOWN AS VESTABURG PLAN OF LOTS, AS ITS PLAN OF LOTS FOR ITS PROPERTY SITUATE PARTLY IN CENTERVILLE BOROUGH AND PARTLY IN EAST BETHLEHEM TOWNSHIP, WASHINGTON COUNTY, PENNSYLVANIA, AND DOES HEREBY DEDICATE FOREVER FOR PUBLIC USE FOR HIGHWAY PURPOSES ALL STREETS, ROADS, LANES AND ALLEYS SHOWN THEREON WITH THE SAME FORCE AND EFFECT AS IF THE SAME HAD BEEN OPENED THROUGH PROPER LEGAL PROCEEDINGS, RESERVING AND EXCEPTING, HOWEVER, TO JONES & LAUGHLIN STEEL CORPORATION, ITS SUCCESSORS AND ASSIGNS, ALL COAL IN AND UNDERLYING SAID STREETS, ROADS, LANES AND ALLEYS, TOGETHER WITH THE FREE AND UNINTERRUPTED RIGHT OF WAY INTO AND UNDER THE LAND ON WHICH SAID STREETS, ROADS, LANES AND ALLEYS ARE LOCATED FOR THE PURPOSE OF DIGGING, MINING, DRAINING AND CARRYING AWAY SAID COAL WITHOUT LIABILITY FOR SURFACE DAMAGE OR DAMAGES OF ANY SORT ARISING THEREFROM OR FROM THE REMOVAL OF ALL OF SAID COAL, AND WITH THE FURTHER PRIVILEGE OF MINING AND REMOVING THROUGH SAID LAND OTHER COAL OF JONES & LAUGHLIN STEEL CORPORATION, ITS SUCCESSORS AND ASSIGNS, NOW OWNED OR HEREAFTER ACQUIRED.

JONES & LAUGHLIN STEEL CORPORATION DOES HEREBY CONSTITUTE AND APPOINT B. F. JONES, 3RD TO BE ITS ATTORNEY FOR IT AND IN ITS NAME, AS AND FOR ITS CORPORATE ACT AND DEED, TO ACKNOWLEDGE THIS ADOPTION BEFORE ANY PERSON HAVING AUTHORITY UNDER THE LAWS OF THE COMMONWEALTH OF PENNSYLVANIA TO TAKE SUCH ACKNOWLEDGMENT TO THE INTENT THAT THE SAME MAY BE DULY RECORDED.
